

**LEBANON BOARD OF EDUCATION  
SPECIAL MEETING - STUDENT DISCIPLINARY MATTER  
WEDNESDAY, May 22, 2018 - 4:00 P.M.**

**Call to Order:** 4:03 p.m. by Jason Nowosad for the purpose of conducting a student expulsion hearing.

**Present:** Jason Nowosad, Albert Vertefeuille, Dawn Whitcher

**Also Present:** Robert Angeli, Superintendent, LMS Principal Robert Laskarzewski, Attorney Richard Mills, Counsel for the Board of Education, the parents of the student who is the subject of the expulsion proceedings, the student who is the subject of the expulsion proceedings.

It is the intention of the Board to conduct the expulsion hearing in Executive Session.

**Motion: J. Nowosad – Move that the Board of Education enter Executive Session for the purpose of discussing confidential student records. Further, I move that the following persons are to be invited into Executive Session to assist in either giving testimony of evidence, or representation of the various parties to the proceedings: Robert Angeli, Superintendent of Schools; LMS Principal Robert Laskarzewski, Attorney Richard Mills, Counsel for the Board of Education, the parents of the student who is the subject of the expulsion proceedings, and the student who is the subject of the expulsion proceedings. Second: A. Vertefeuille Vote: Unanimous. Entered Executive Session at 4:05 p.m.**

Return to Public Session at 4:50 p.m.

**Motion made by J. Nowosad and seconded by A. Vertefeuille - MOVED, that the Board finds, based on the evidence in the record, that the student who is the subject of this hearing did, on or about May 14, 2018, possess a knife during the school day on school grounds. Such conduct violated a publicized policy of the Board, endangered persons or property, and was seriously disruptive of the educational process.**

**The student shall be expelled from school for one calendar year, through and including May 22, 2019. The student will be provided an alternative educational program during the period of expulsion as provided by law. During the period of the expulsion the student shall not be allowed to enter any school property and/or participate in any school sponsored events and activities, except for educational purposes as determined by the Administration.**

**The Student will be eligible for early readmission to school on the first day of the 2018-19 academic year if the Superintendent finds, in his sole discretion, that the student has met the following conditions:**

- 1. The Student has good attendance and makes a good faith effort in all aspects of the alternative education program;**
- 2. The Student refrains from engaging in any conduct that would warrant suspension or expulsion under the policies of the Board.**

**If the student is readmitted early, and if the student thereafter engages in any conduct that would warrant suspension or expulsion under the policies of the Board, the Superintendent is authorized to reinstate the remaining term of the student's expulsion without the necessity of any further action by the Board.**

**Motion passed unanimously.**
